Period of coverage of the policy: From 01/01/2018 to 31/12/2018.

SPORT-ACCIDENT INSURANCE SUMMARY - ALLIANZ

Insurance number: 04056202048

- Death by sports accident: 9,000 €.
- Permanent disability due to sports practice (up to a maximum of) 18,000 €.
- Medical and surgical assistance in Spain for 18 months in UNLIMITED amount and with the following conditions:

- All medical expenses during admission to Allianz-Authorized Concerted Centers.
- 70% of the orthopedic material required as a result of a sports accident covered by the policy. (not preventive material)
- Dentistry expenses necessary as a result of a sports accident up to 250 €
- Expenses for the first transfer and evacuation of the injured person to clinics indicated by Allianz, by ambulance or other similar transport, in the case of a serious and urgent injury or if the injured person needs to be admitted.
- Transport by ambulance or similar means from the Medical Centre to your home is excluded.

- In the event of an ACCIDENT, it is essential to call the 24-hour helpline of ALLIANZ 902.102.687 where the injured person will be informed of the nearest Health Centre where he or she can be attended to in an Emergency.

In case of a stay in a medical centre NOT CONCERTED, ALLIANZ will not assume the payment of the invoices derived from the services rendered.

- Medical coverage for sports accidents outside Spain Up to 6.100 €
- Transfer and repatriation expenses Included in total medical expenses
- Extension of coverage, worldwide (except USA and Canada)

Procedure in **Spain**: Assistance in authorized centres. Complete the Federation's accident form, or Club, and report the accident by calling **902 102 687** (24 hours).

Procedure **outside Spain**: report the accident by calling **+34 902 102 687**

To claim reimbursement of medical expenses (outside Spain) you must submit the original bills paid by the injured party, medical report, along with a letter issued by the club or centre where the accident occurred, explaining the circumstances of the accident.

There is a franchise of 150 € to be paid by the federated person responsible for the damage. In the case of CR CR, this amount will be 300 €.

Worldwide coverage except USA and Canada

Claims Procedure: A letter must be submitted explaining the circumstances of the accident issued by the club or center where the accident occurred, including all original invoices.
